### **1. General rules**

- All participants must be children of OHLA Group employees.
- All participants will be divided into 2 categories:
  - 1st category: children between 3 and 7 years old.
  - 2nd category: children between 8 and 12 years old.
- Each drawing must be presented on a white cardboard sheet, DIN-A4 size.
- The subject matter of these drawings will be Christmas, related to OHLA.
- Any drawing materials may be used (pencils, crayons, watercolors, collage, felt-tip pens, etc.)
- Only one drawing per participant may be submitted

### **2. Sending**

- Each drawing will be sent by e-mail to [sostenibilidad@ohla-group.com](mailto:sostenibilidad@ohla-group.com) indicating “XVIII Drawing Competition Candidature” in the reference, for ease of reference.
- If scanning the picture, please ensure the highest possible resolution given that this year attachments are still received by e-mail to avoid unsustainable paper use.
- The following identity details will be indicated alongside the drawing: author’s full name, author’s age and date of birth, category of participant, full name of the father/mother, and father/mother’s work position and country.
- Furthermore, this year you may share photos, videos or voice messages with us, related to the creative process. The final result is just as important as the making-of! ### **3. Choosing the winner drawings**

- A shortlist will be drawn up by Sustainability amongst the finalist drawings.

### **5. Deadline for receipt of drawings**

The timeframe in which to receive drawings will begin on **11 th November and will end on 10th December 2025**. Any drawings received after this date will not be accepted.

Drawings that fail to meet the conditions established in these competition terms will be rejected.

The winners will be announced on 16th December in various corporate channels. All winners will receive their prize within two weeks maximum.
